TOWNSHIP OF FAIRFIELD ORDINANCE # 2003-04

**AN ORDINANCE AMENDING SECTION 4-4.5 OF THE CODE OF THE
TOWNSHIP OF FAIRFIELD REGARDING INSURANCE
REQUIREMENTS FOR TAXICABS AND LIMOUSINES**

WHEREAS, the Mayor and Council of the Township of Fairfield has reviewed its ordinances with regard to the licensing of taxicabs and limousines; and


WHEREAS, the Mayor and Council have determined that it is in the best interest of the citizens of the Township of Fairfield as well as businesses in the Township of Fairfield to provide for insurance requirements consistent with State Statute N.J.S.A. 48:16-14,

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:

I. Section 4-4.5 Insurance Required. This section of the Code of the Township of Fairfield be and is hereby amended to read as follows:

No taxicab license shall be issued until the applicant has filed with the Township Clerk an insurance policy, of a company duly licensed to transact business under insurance laws of the State of New Jersey, in the sum of one million five hundred thousand (\$1,500,000.00) dollars against loss by reason of the liability imposed by law upon every limousine or taxicab owner for damages on account of property damage, bodily injury or death suffered by any person as a result of an accident occurring by reason of the ownership, maintenance or use of the taxicab or limousine upon any public street. Any license issued for any such operation of the taxicab thereunder shall be permitted only so long as the insurance policy shall remain in force to the full and collective amounts aforesaid. The insurance policy shall provide for the payment of any final judgment recovered by any person on account of the ownership, maintenance and use of such taxicab or any fault in respect thereto, and shall be for the benefit of every person suffering loss, damage or injury as aforesaid.

2. This ordinance shall take effect immediately upon passage and publication in accordance with law.
