

**TOWNSHIP OF FAIRFIELD
ORDINANCE #2009-02**

**AN ORDINANCE AMENDING CHAPTER 2-11
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD
REGARDING OFF-DUTY HOURLY RATES
FOR POLICE OFFICERS**

WHEREAS, the Township of Fairfield approves an Ordinance to amend Section 2-11 of the Code of the Township of Fairfield and add to it section 2-11.15 regarding Off-Duty Hourly Rates for Police Officers; and

WHEREAS, based upon the foregoing the Governing Body of the Township of Fairfield has found it necessary to increase its rate for Off-Duty Hourly Rates for Police Officers; and since the Township of Fairfield has not had such an Ordinance previously, wishes to add to the Code section 2-11.15; and

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, AND STATE OF NEW JERSEY AS FOLLOWS:

1. Chapter 2-11.15 be and is hereby added to read as follows:
 - a. As of January 1, 2009, contractors requesting officers to work off-duty traffic and security jobs pay the following rates:
 1. Officer – Sixty dollars and no cents (\$60.00);
 2. Police Vehicles – Fifteen dollars and no cents (\$15.00);
 3. Administration Fee – Five dollars and no cents (\$5.00).
2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause of provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
