

**TOWNSHIP OF FAIRFIELD
ORDINANCE #2010-01**

**AN ORDINANCE AMENDING CHAPTER 45 ZONING SECTION 42.7
"PERMITS"
OF THE TOWNSHIP OF FAIRFIELD**

WHEREAS, the Attorney to the Governing Body is requesting that Chapter 45 – Zoning, Section 42.7 Permits be deleted from the Code Book as it is incorrectly giving the Governing Body powers that should only be administered by the Zoning Board of the Township of Fairfield, County of Essex, State of New Jersey;

WHEREAS, based upon the foregoing, the Governing Body of the Township of Fairfield approves the deletion of Section 42.7 from the Code Book in its entirety at the January 25, 2010 meeting.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:

1. Chapter 45 Section 42.7 Permits shall be deleted in its entirety as follows:

~~45-42.7 Permits.~~


- ~~a. A developer of a project recurring creation or establishment of a prohibited land use or any vertical height development shall first apply for development approval from the Governing Body of the Township of Fairfield. If the Governing Body approves the development, that approval shall be strictly conditioned on the developer applying for and receiving a permit from the Commissioner of the Department of Transportation in accordance with the provisions of N.J.A.C. 16:62-1.1 et seq. Construction, development or creation of any prohibited land use shall not commence until a permit has been issued by the Commissioner.~~
- ~~b. In review of any application, the Governing Body may take into consideration any factor relevant to the hardship demonstrated by the applicant and any information relevant to the public health, safety and welfare.~~
- ~~c. In acting upon such an application, the Governing Body shall consider the following:
 - ~~1. The prohibited land use or vertical height development will not, in fact, create an additional airport hazard limiting the size of the area available for landing, taking off and maneuvering of the aircraft.~~~~

~~2. The prohibited land use or vertical height development will not harm the public health, safety and welfare.~~


~~d. Any person proposing to create or establish a prohibited land use or vertical height development in a designated airport safety zone not subject to municipal ordinances established in accordance with the Municipal Land Use Law (N.J.S.A. 40:55D) shall present the proposed development to the governing body.~~

2. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this Ordinance shall be deemed valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
