

**TOWNSHIP OF FAIRFIELD  
ORDINANCE #2012-14**

**AN ORDINANCE AMENDING CHAPTER 7-37.2  
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD  
REGARDING CHANGES TO TRAFFIC REGULATIONS**

**WHEREAS**, the Mayor and Governing Body of the Township of Fairfield request changes be made to the Ordinance prohibiting a left hand turn from 4 Little Falls Road (Merchant House Tavern) driveway onto Little Falls Road; and

**WHEREAS**, at the request of the Governing Body, Chapter 7-37.2 shall be amended to include the no left hand turn from the driveway of Merchant House Tavern onto 4 Little Falls Road to; and

**WHEREAS**, based upon the foregoing, the Governing Body of the Township of Fairfield has found it necessary to amend the Ordinance and finds the change to be in the best interest of Fairfield Township.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND  
COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE  
OF NEW JERSEY AS FOLLOWS:**

1. Chapter 7-37.2 REGULATION FOR THE MOVEMENT AND THE PARKING OF TRAFFIC ON PRIVATE PROPERTY OPEN TO THE PUBLIC AND TO WHICH THE PUBLIC IS INVITED (RETAIL BUSINESS). be and is hereby amended to read as follows:

*Regulation*


**4 Little Falls Road**

**No left turn from driveway onto  
Little Falls Road**

There are no other changes to this section.

2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause of provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.

4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
