

**TOWNSHIP OF FAIRFIELD  
ORDINANCE #2012-15**

**AN ORDINANCE AMENDING CHAPTER 18-1.5  
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD  
REGARDING APPLICATION FOR WATER MAIN, TAP AND  
WATER SUPPLY LINE TO CURB**

**WHEREAS**, the Mayor and Governing Body of the Township of Fairfield request changes be made to the Ordinance regarding existing fees for service of tap service applications for water main, tap and water supply lines to the curb; and

**WHEREAS**, at the request of the Governing Body, Chapter 18 – 1.5 shall be amended to reflect fees incurred by the Township or fees waived by the Township with respect to installation of tap service, service piping and curb stop installed to a property; and


**WHEREAS**, based upon the foregoing, the Governing Body of the Township of Fairfield has found it necessary to amend the Ordinance and finds these changes to be in the best interest of Fairfield Township.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND  
COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE  
OF NEW JERSEY AS FOLLOWS:**

1. Chapter 18-1.5 be and is hereby amended to read as follows:
  - a. Shall remain unchanged..
  - b. **Should there be an existing service; inclusive of tap, service piping and curb stops installed to the property; installed by the Township of Fairfield at the Township's expense, then fees in accordance with Chapter 18-1.6 shall apply.**
  - c. **Should there be an existing service; inclusive of tap, service piping and curb stops installed to the property; installed at no expense to the Township of Fairfield, then fees in accordance with Chapter 18-1.6 shall be waived.**
  - d. (Existing subsection b. shall now become subsection d.)
2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause of provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to

that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.

4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
