

**TOWNSHIP OF FAIRFIELD
ORDINANCE #2013-12**

**AN ORDINANCE AMENDING CHAPTER 7
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD
REGARDING ADDING STOP SIGNS**

WHEREAS, the Police Department of the Township of Fairfield request changes be made to the Ordinance for the purpose of adding stop signs at stop intersections that presently do not have any stop signs; and

WHEREAS, at the request of the Police Department, Chapter 7 Section 7.20 shall be amended to include a list of new intersections requiring stop signs; and

WHEREAS, based upon the foregoing, the Governing Body of the Township of Fairfield has found it necessary to amend the Ordinance and finds the change to be in the best interest of Fairfield Township.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND
COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE
OF NEW JERSEY AS FOLLOWS:**

1. Chapter 7 Traffic – Section 7.20 Stop Intersections. The following stop signs shall be added on the designated and the Section shall be and is hereby amended to read as follows:

- 1. A stop sign on Long Acres Road approaching Knoll Road, a stop sign on Knoll Road entering Long Acres Road, and a stop sign on Long Acres Road coming from Cole Road.**
- 2. A stop sign on Long Acres Road approaching Cole Road and a stop sign on Cole Road entering Long Acres Road. A stop sign on Long Acres Road approaching Cole Road from the opposite direction.**


The following has been adopted under Ordinance for stop signs, but do not have any signage or lane markings posted:

The following locations have been adopted by Ordinance, and have stop signs, but do not have stop lines painted:

**Caryn Place & Alan Drive
Stewart Place & Gardner Road (both sides of intersection).**

3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
