**TOWNSHIP OF FAIRFIELD  
ORDINANCE #2013-23**

**AN ORDINANCE AMENDING CHAPTER 7  
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD  
REGARDING SPEED LIMITS**

**WHEREAS**, the Police Department of the Township of Fairfield has conducted a traffic study and determined that it has become necessary to change a speed limit on a specific roadway within Fairfield Township; and

**WHEREAS**, the Police Department requests that Chapter 7 Section 36 be amended so that the speed limit be reduced to 25 m.p.h on Big Piece Road to make it a safer roadway; and

**WHEREAS**, based upon the foregoing, the Governing Body of the Township of Fairfield agrees that amending the Ordinance is in the best interest of Fairfield Township.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:**

**7-36 SPEED LIMITS.**

Speed limits shall be established as follows: Regulatory and warning signs, conforming to the current Manual on Uniform Traffic Control Devices for Streets and Highways, shall be erected and maintained to effect the designated speed limit(s), as required by the Commissioner of Transportation of the State of New Jersey and as specified and authorized in writing from the Bureau of Traffic Engineering of the Department of Transportation. 


and the remainder of this ordinance shall be deemed to be valid and effective.
