

**TOWNSHIP OF FAIRFIELD
ORDINANCE #2014-01**

**AN ORDINANCE AMENDING CHAPTER 18-2.4
OF THE CODE OF THE TOWNSHIP OF FAIRFIELD
REGARDING WATER SERVICE CHARGES**

WHEREAS, the Passaic Valley Water Commission adopted a five-year comprehensive operating and capital plan in 2009, underwent extensive budget reviews for years since and updated the plan for 2014-2018, and commissioned a Cost of Service Allocation Study to ensure that rates are equitable while meeting the Passaic Valley Water Commission's legal and fiduciary responsibilities; and

WHEREAS, effective February 1, 2014, the wholesale water rates will increase from \$2,187.84 per MGD to \$2,297.23; and

WHEREAS, based upon the foregoing, the Governing Body of the Township of Fairfield has found it necessary to increase its rate for water service charges to its residents, in order to offset increases from the Passaic Valley Water Commission.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:

1. Chapter 18-2.4 be and is hereby amended to read as follows:
 - a. The quarterly charges for water consumed at the building or buildings on the premises served, as measured by the water meter, shall be as follows:
 1. Zero (0) to fifteen thousand (15,000) gallons: ~~fifty (\$50.00) dollars for 2013;~~ **fifty-two dollars fifty cents (\$52.50) for 2014.**
 2. Above 15 thousand (15,000) gallons: ~~four dollars and twenty-five cents (\$4.25) for 2013;~~ **four dollars fifty cents (\$4.50) for 2014** for every additional one thousand (1,000) gallons.
 - b. Billings for water consumed at each building shall be determined by the Water Department.
 - c. The filing of residential swimming pools located within approximately three hundred (300) feet of an available water hydrant shall be performed by the Municipal Water Department at a flat fee to the owner or occupant in the amount of one-hundred eighty-five (\$185.00) dollars payable in advance.



3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
