**AN ORDINANCE TO AMEND AND  
SUPPLEMENT THE REVISED ORDINANCES OF THE  
TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX  
SETTING THE EFFECTIVE DATE FOR SEWER RATE ADJUSTMENT AND WATER  
SERVICE CHARGES FOR THE YEAR 2015 AS JANUARY 1, 2015**


**WHEREAS**, the Mayor and Council of the Township of Fairfield have amended the water rate and sewer rate as required by law; and

**WHEREAS**, Ordinance 2015-02 incorrectly set an effective date of February 1, 2015 and Ordinance 2015-03 fails to set an effective date for the Sewer increase; and

**WHEREAS**, it was the intent of the Governing Body to establish these increases for the entire year of 2015 and so the effective date for both ordinances needs to be amended to set January 1, 2015 as the effective date for both ordinances.

**NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY AS FOLLOWS:**

1. That Fairfield Ordinances 2015-02 and 2015-03 are both hereby amended to set January 1, 2015 as the effective date for the increase in the Township's Water Service Charges found in Chapter 18 Section 2.4 and for the increase in the Township's Sewer Charges found in Chapter 17 Section 5.1.
2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
