WHEREAS, Fieldfair Corp., a New Jersey Corporation, is the assessed owner of property identified as Block 4204, Lots 24 & 27-34, and Block 3603, Lot 4, on the official Tax Map of the Township of Fairfield; and

WHEREAS, Fieldfair Corp., wishes to donate said property to the Township of Fairfield; and

WHEREAS, Fieldfair Corp., obtained a Phase I and Phase II environmental impact study dated May 11, 2015 and June 29, 2015, respectively; and

WHEREAS, after completion of the Phase II environmental impact study, the investigative agency concluded that no further investigation or remediation is warranted; and

WHEREAS, the Township obtained a Title Report dated August 5, 2015, which established a clear title history free from any encumbrances with the exception of various utility and drainage easements; and

WHEREAS, N.J.S.A. 40A:12-5(a)(1) authorizes a municipality to accept property as a gift by the adoption of an ordinance authorizing the acquisition of the same.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Fairfield, County of Essex, State of New Jersey, as follows:

SECTION 1. The governing body does hereby authorize the acquisition of Block 4204, Lots 24 & 27-34, and Block 3603, Lot 4 by gift from Fieldfair Corp.

SECTION 2. That the Mayor and Municipal Clerk are hereby authorized to execute any and all documents necessary for the acquisition of the subject property from Fieldfair Corp.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.
