**AN ORDINANCE AMENDING CHAPTER 24-2.14(g)
OF THE TOWNSHIP CODE OF THE TOWNSHIP
OF FAIRFIELD RELATING PERMIT FEES FOR
ATHLETIC AND PARK FIELDS**

NOW, THEREFORE BE IT ORDAINED by the Mayor and Township Council of the Township of Fairfield, County of Essex, State of New Jersey, as follows:

SECTION 1. Chapter 24-2.14(g), entitled “Athletic Fields and Recreational Facilities Use Policy,” of the Township Code of the Township of Fairfield is hereby amended as follows:

§ 24-2.14. Athletic Fields and Recreational Facilities Use Policy.

g. *Permit Fees.*

1. Fairfield Township Athletic and Park Fields.

...

Category 2A and 3A Permit Fees:

~~\$225.00~~ \$275.00 per team per season (half-day rental)
Cost includes practice and game scheduling

~~\$25.00~~ \$50.00 per field, for a daily use (half-day rental)
Cost is for a single day(s) need if not in season or
not applying for a season permit

...

Category 2B and 3B Permit Fees:

~~\$450.00~~ \$550.00 per team per season (half-day rental)
Cost includes practice and game scheduling

~~\$50.00~~ \$100.00 per field, for a daily use (half-day rental)
Cost is for a single day(s) need if not in season or not applying for a season permit

...

SECTION 2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, paragraph, subdivision, clause of provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section,


paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.


