TOWNSHIP OF FAIRFIELD **ORDINANCE #2017-10**

AN ORDINANCE AMENDING CHAPTER 7, ARTICLE 37, SECTION 2 OF THE TOWNSHIP CODE OF THE TOWNSHIP OF FAIRFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY, PROHIBITING LEFT TURNS FROM DESIGNATED PROPERTY

WHEREAS, the Fairfield Township Planning Board granted Site Plan Approval for Thatcher McGhee's, located at 31 Passaic Avenue in the Township of Fairfield, wherein as a condition of approval "there shall be a 'No Left Turn' sign posted at the exit from the parking lot onto Passaic Avenue"; and

WHEREAS, Chapter 7, Article 37, Section 2 needs to be amended to provide for that restriction so that the Fairfield Township Police Department can enforce same; and

WHEREAS, based upon the foregoing, the Governing Body of the Township of Fairfield agrees that amending the Ordinance to prohibit left turns from Thatcher McGhee's onto Passaic Avenue is in the best interest of Fairfield Township.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Fairfield, County of Essex, State of New Jersey, as follows:

SECTION 1. Section 7-37.2, entitled "Regulation for the Movement and the Parking of Traffic on Private Property Open to the Public and to Which the Public Is Invited (Retail Business)," of the Township Code of the Township of Fairfield shall be amended as follows:

§ 7-37.2 Regulation for the Movement and the Parking of Traffic on Private Property Open to the Public and to Which the Public Is Invited (Retail Business).

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
